## Attachment: RE:ACT Membership Rules

1. Reading and agreeing to abide by the following code of conduct.

2. Supporting the collective's mission, vision, goals and objectives. You therefore need to respect and support all kinds of arts, independent of someone's personal taste.

3. Being actively engaged, participating in meetings and events and support them.

4. Protecting the integrity of the collective and promoting a positive public image.

5. Maintaining proper and respectful interpersonal relations with other members and non-collective members when acting as a member or representative of the collective. Therefore racism and discrimination of any kind, be it towards gender, sexuality, ethnicity, someone's disability or profession is not accepted.

6. Members must pay the periodic membership fee in order to maintain their membership.

7. In case a member leaves RE:ACT or gets excluded the paid amount at this point in time can not be paid back but remains part of the collective's account.

8. In the exceptional case of heavy violation of the above rules a member can be excluded from the collective. Such exceptional cases can be repeatedly not paying the membership fee or showing great disrespect against other members from both an interpersonal perspective and in terms of being strongly unreliable concerning f.e. missed deadlines and sudden cancellations in projects.

9. As a member of RE:ACT you respect artists and art lovers of any profession and background and share our mentality and intention of sustaining a free and open space for such.

10. Work performed within RE:ACT is also an intellectual property which can be seen under RE:ACT e.V. If a contributor leaves a project before its termination, the association is allowed to use the already finished work of this person for the completion of the respective project.

As long as it's not clearly unwanted by the respective artist RE:ACT e.V. is allowed to use his/her work for Social Media campaigns, even if this person is no longer a member of RE:ACT.
